



PRIVACY POLICY - SPONTIME

Last updated: 17 February 2017

This privacy policy governs your use of the software application Spontime ("Application") for mobile devices that was created by Spontime Inc.

What information does Spontime obtain and how is it used?

User Provided Information

The Application obtains the information you provide when you download and register the Application. Registration with us is optional. However, please keep in mind that you may not be able to use some of the features offered by the Application unless you register with us.

When you register with us and use the Application, you generally provide:

- (a) your name, email address, friend list and other information from Facebook you provide us during registration;
- (b) information you provide us during onboarding process: name, gender, interests
- (c) information you provide us when you contact us for help;
- (d) information you enter into our system when using the Application.

We may also use the information you provided us to contact you from time to time to provide you with important information, required notices and marketing promotions.

Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, geo-targeting data, and information about the way you use the Application.

With your approval, we may also collect your login information, contact information, your photos, friends list or check-ins from Facebook and other social networking sites.

Does Spontime collect precise real time location information of the device?

When you visit the mobile application, we may use GPS technology to determine your current location in order to determine the place you are located within and display a location



map with relevant advertisements. We will not share your current location with the third parties.

If you do not want us to use your location for the purposes set forth above, you should turn off the location services for the mobile application in your mobile phone settings.

What other information may Spontime access?

You may provide Spontime with the access to your camera, photo library, and phone contacts. It allows you to upload your own photos to your profile, and invite friends to Spontime. Spontime will also collect the information about what activities you create and join. Spontime will not share these information with third parties.

Why does Spontime collect these information?

Spontime collects all the information in good faith, to ensure the application is used to its full potential, and to provide the users with fun experiences and most importantly, safety and security. Spontime is a meeting application, therefore there is nothing more important for us than having a credible and trustworthy community of users. The more information we collect, the more verified the user profiles.

Do third parties see or have access to information obtained by Spontime?

In exceptional situations, we may disclose User Provided and Automatically Collected Information:

- as required by law, such as to comply with a subpoena, or similar legal process;
- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- with our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.
- if Spontime is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information.



What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

You may also opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address support@spontime.co:

- See what data we have about you, if any.
- Change or correct any data we have about you.
- Express any concern you have about our use of your data.

Cookies

In addition to User Provided and Automatically Collected Information through the Application, we use "cookies" on the website www.spontime.co. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance the experience on our site.

Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the Application, please contact us at support@spontime.co. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Children

We do not use the Application to knowingly solicit data from or market to children under the age of 13. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at support@spontime.co. We will delete such information from our files.



Security

We are concerned about safeguarding the confidentiality of your information. We limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.

Changes

This Privacy Policy may be updated from time to time for any reason. You are advised to consult this Privacy Policy regularly for any changes, as continued use is deemed approval of all changes.

Your Consent

By using the Application, you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. "Processing," means using cookies on a computer/hand held device or using or touching information in any way, including, but not limited to, collecting, storing, deleting, using, combining and disclosing information.
